## **Election of the Office Bearers for the term 2024-2026**

**Dear Member,**

In the Annual General Meeting of the Society held in December, 1984 it was decided that the election of the Office Bearers of the Society will be held by **Postal Ballot**. In this connection, I may refer to the Article Nos. 6 and 7 of the constitution, a copy of which was sent to you earlier. However, for ready reference relevant portion of the article 6 (Executive Committee) is quoted below.

**Article 6:** Executive committee (E.C.):

Article 6: Executive Committee

- i) Executive Committee of the Society shall consist of the following nineteen persons: (a) President- one, (b) Vice-Presidents- two, (c) Secretary General, (d) Joint Secretary Generals- two, (e) Treasurer and (f) Members- seven. In addition to the above seven members, the outgoing Secretary General will be an Ex-officio member if he/she is not re-elected as secretary General or elected in any other post. The two Chief Editors (of the Journal and the Uddid Barta) shall be Ex-officio Members. The Executive committee shall co-opt two (if Ex-Secretary General is an ex-officio Members) or three (if the Secretary General is not an ex-officio member) distinguished Plant scientists (who are members of the Bangladesh Botanical Society) as members. One Vice President, Secretary General, Treasurer and one Joint Secretary General must be the resident members of Dhaka Metropolitan City and employed in an Institution/organization of the Dhaka Metropolitan City. All dues to the Society must be paid before submitting nomination for any post of the Executive Committee. If one or both of the Chief Editors are selected from amongst the members of newly elected E.C., then co-opt one/two (one for each), from the general members. Since the term of office of the present Executive committee is upto next AGM, it is desired that the election of the new Committee be held before the next Annual General Meeting.
